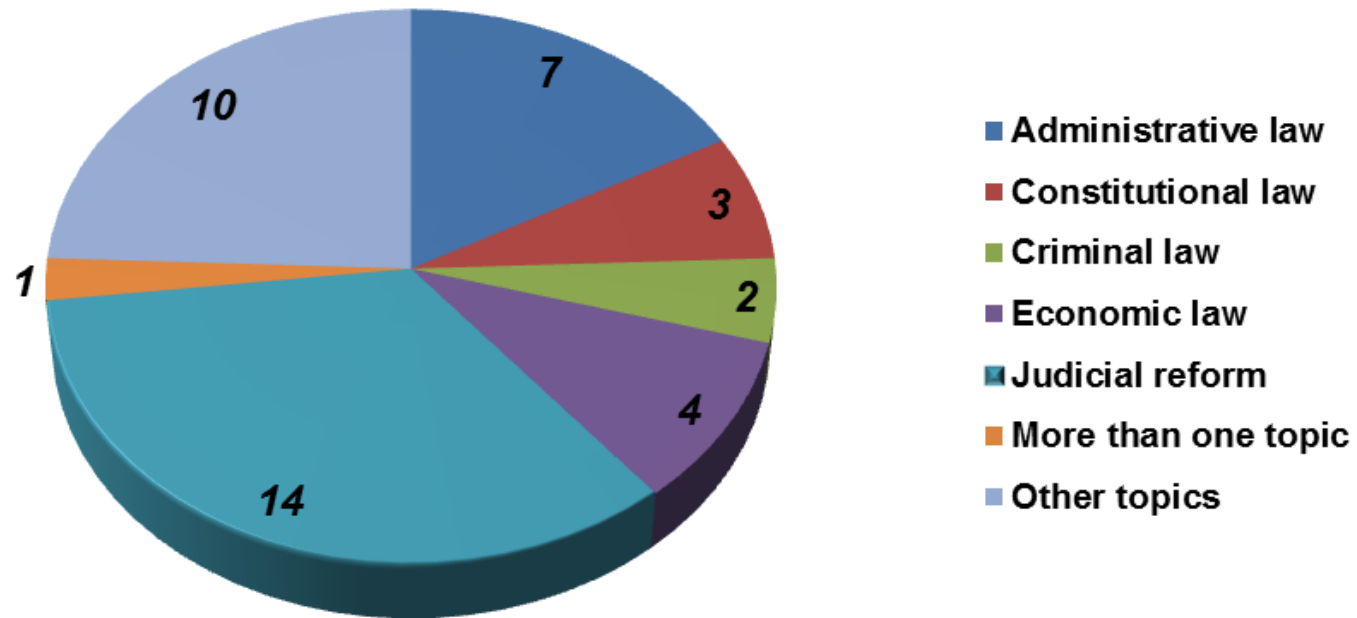

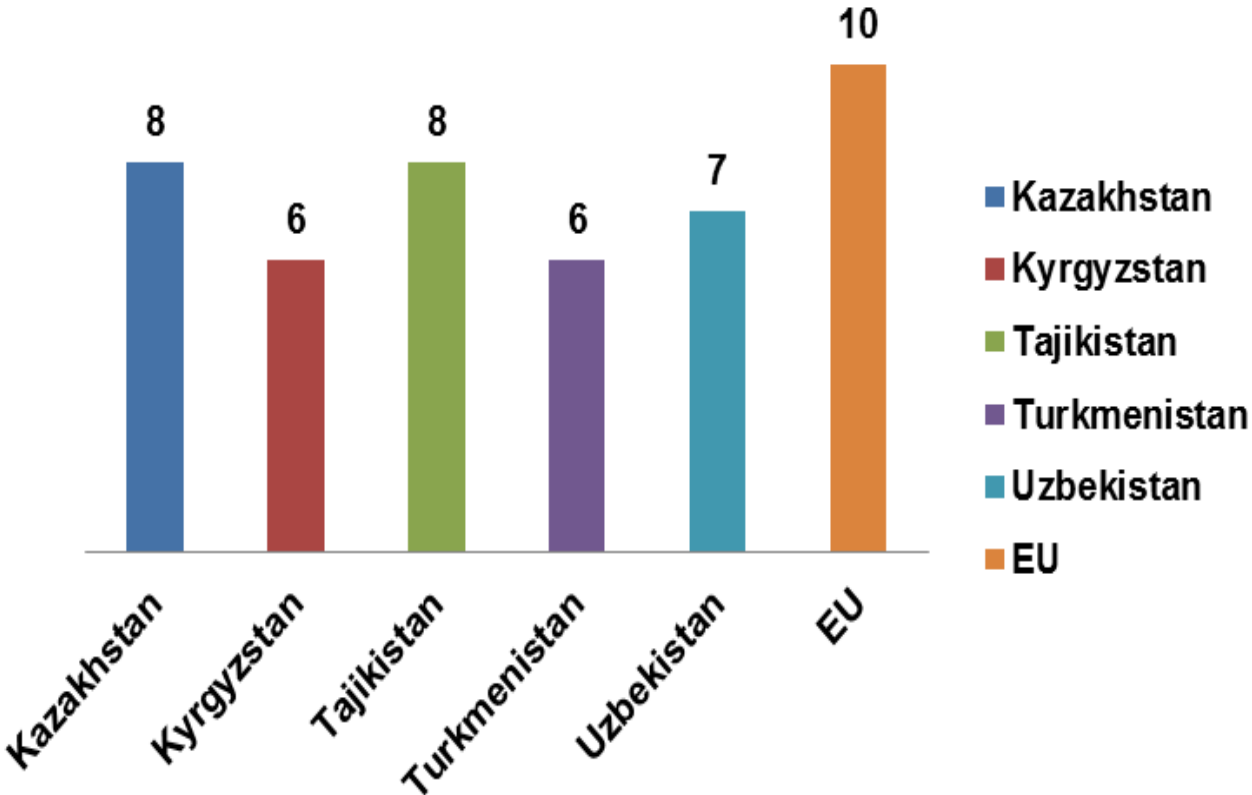

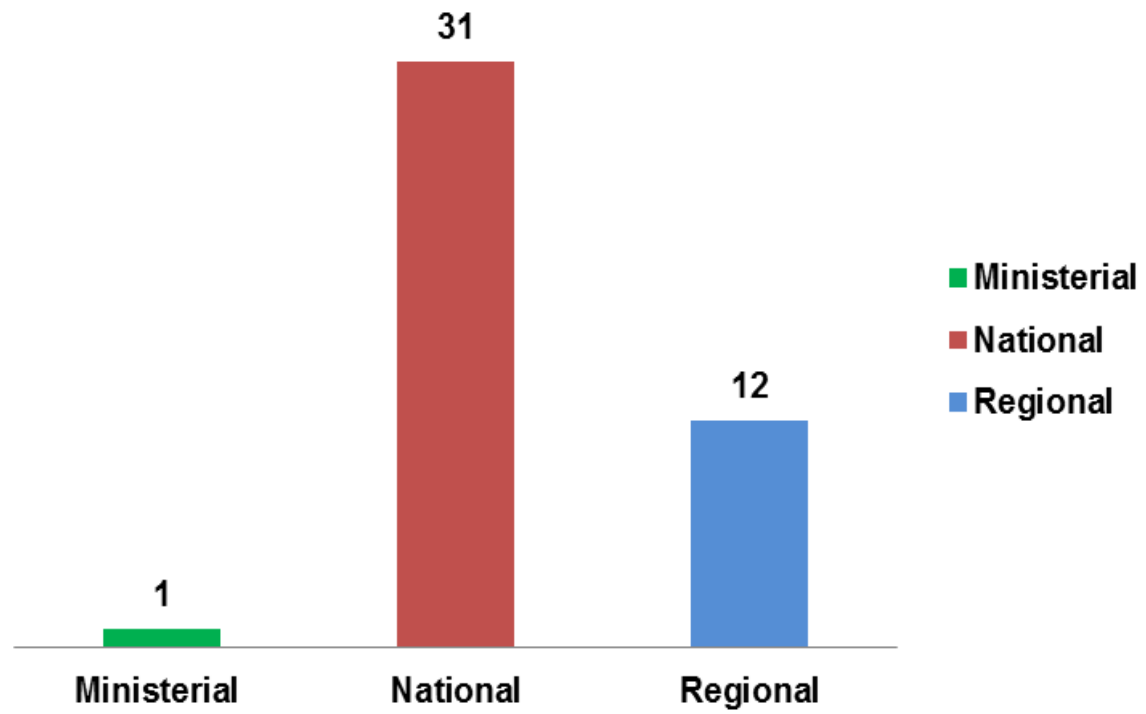
Activities by subject matter
